Agistor's Obligations:

The Agistor agrees to provide reasonable care, feed, water, shelter, and management of the stock during the agistment period. The Agistor shall comply with all relevant laws and regulations and maintain the agistment property in a suitable condition.

Owner's Obligations:

The Owner shall ensure that all stock delivered for agistment is healthy, suitably identified, and complies with all relevant legislation. The Owner must notify the Agistor promptly of any health or welfare issues. The Owner is responsible for all costs associated with veterinary treatment, transport, and stock insurance.

Termination:

Either party may terminate this Agreement by giving the other party written notice as stipulated in the agistment period or reasonable notice if the agistment period is indefinite. On termination, the Owner shall remove the stock within a reasonable time. The Agistor may charge agistment fees up to the date of removal.

Liability and Indemnity:

The Agistor shall not be liable for loss, injury, or death to the stock except where caused by the Agistor's negligence or breach of this Agreement. The Owner indemnifies the Agistor against all claims, losses, or damages arising from the Owner's breach, negligence, or acts.

Insurance:

The Owner is responsible for insuring the stock against loss, injury, disease, or death while on agistment. The Agistor is responsible for insuring the agistment property and any improvements, but not the Owner's stock.

Dispute Resolution:

The parties agree to attempt to resolve any dispute arising out of or in connection with this Agreement through negotiation in good faith. If unresolved, the dispute shall be referred to mediation before commencing any legal proceedings.

Governing Law:

This Agreement is governed by the laws of the State of Queensland, Australia. The parties submit to the non-exclusive jurisdiction of the courts of Queensland.

Entire Agreement:

This Agreement constitutes the entire agreement between the parties concerning the subject matter and supersedes all prior agreements, arrangements, and understandings.

Severability:

If any provision of this Agreement is held to be invalid, illegal, or unenforceable, the remaining provisions shall continue in full force and effect.

Waiver:

No waiver of any breach of this Agreement shall be deemed a waiver of any other or subsequent breach.
