Clause 1 – Agreement to Sell and Purchase

The Seller agrees to sell and the Buyer agrees to purchase the described vehicle on the terms and conditions set out in this Agreement. Both parties warrant they have the legal authority to enter into this Agreement.

Clause 2 – Vehicle Condition; AS IS

The vehicle is sold 'AS IS' without warranties or guarantees, either expressed or implied, except as required by Australian Consumer Law and as expressly stated in this Agreement. The Buyer acknowledges having had the opportunity to inspect the vehicle prior to purchase.

Clause 3 – Ownership and Title

The Seller warrants that they are the lawful owner of the vehicle and that the vehicle is free from all encumbrances, liens, or any other third-party interests at the time of sale.

Clause 4 – Registration and Transfer

The Seller shall provide all necessary documents required to effect the transfer of registration and ownership to the Buyer in accordance with applicable Australian state or territory laws.

Clause 5 – Payment

Full payment of the Purchase Price shall be made by the Buyer as agreed upon in this Agreement. Title and possession of the vehicle shall not pass to the Buyer until full payment is received.

Clause 6 – Risk

Risk in the vehicle passes to the Buyer upon delivery or possession of the vehicle, whichever occurs first.

Clause 7 – No Warranty of Fitness

Except where required by law, the Seller makes no warranty that the vehicle is fit for any particular purpose or use.

Clause 8 – Disclosure of Defects

The Seller has disclosed any known defects or issues with the vehicle to the Buyer prior to the execution of this Agreement.

Clause 9 – Governing Law

This Agreement shall be governed by, and construed in accordance with, the laws of the Commonwealth of Australia and the relevant State or Territory.

Clause 10 – Entire Agreement

This document constitutes the entire Agreement between the parties and supersedes all prior negotiations, representations, or agreements, whether oral or written.

Clause 11 – Amendments

Any amendments or variations to this Agreement must be in writing and signed by both parties.

Clause 12 – Severability

If any provision of this Agreement is held invalid or unenforceable, the remainder of the Agreement shall remain valid and enforceable.

Clause 13 – Dispute Resolution

Any dispute arising from or related to this Agreement shall be resolved amicably between the parties or, if required, through mediation or legal proceedings in the appropriate Australian jurisdiction.

Clause 14 – Signatures

This Agreement may be executed in counterparts and signed electronically or in person. Each counterpart shall be deemed an original.

Clause 15 – Personal Information

The parties agree to use and protect any personal information provided in accordance with Australian Privacy Principles and applicable privacy legislation.
