Clause 1 – Agreement to Provide Services or Goods

Party A agrees to provide and Party B agrees to accept the services or goods described above, subject to the terms and conditions of this Contract.

Clause 2 – Term

This Contract shall commence on the date of signing and shall continue for the period specified above or until the completion of the services or delivery of goods, unless terminated earlier in accordance with this Contract.

Clause 3 – Payment

Party B shall pay Party A the total amount stated above in accordance with the payment method and schedule specified. All payments shall be made in Australian Dollars (AUD).

Clause 4 – GST and Taxes

If applicable, the payments under this Contract are exclusive of Goods and Services Tax (GST). Party A shall provide a valid tax invoice for all payments. Each party shall be responsible for their own taxes arising under this Contract as required by Australian law.

Clause 5 – Obligations of Party A

Party A shall perform the services or deliver goods with due care, skill, and diligence in accordance with all applicable laws and standards prevailing in Australia.

Clause 6 – Obligations of Party B

Party B shall cooperate with Party A as reasonably required to enable Party A to perform its obligations under this Contract.

Clause 7 – Confidentiality

Each party agrees to keep confidential all information received from the other party that is not publicly available and to use such information only for the purposes of this Contract.

Clause 8 – Liability and Indemnity

To the extent permitted by law, Party A's liability for any claim arising under this Contract is limited to the total amount paid under this Contract. Neither party shall be liable for indirect or consequential loss. Each party indemnifies the other from any claims arising from breach of this Contract or negligent acts.

Clause 9 – Termination

Either party may terminate this Contract by providing written notice to the other party if the other party breaches any material term of this Contract and fails to remedy such breach within fourteen (14) days of receiving written notice.

Clause 10 – Dispute Resolution

The parties agree to attempt to resolve any disputes arising under this Contract amicably and in good faith. If unresolved, disputes shall be submitted to mediation or arbitration in accordance with Australian law.

Clause 11 – Governing Law and Jurisdiction

This Contract shall be governed by and construed in accordance with the laws of the Commonwealth of Australia and the State or Territory in which Party A operates. The parties submit to the exclusive jurisdiction of the courts of that State or Territory.

Clause 12 – Entire Agreement

This Contract, including any annexures or schedules, constitutes the entire agreement between the parties and supersedes all prior agreements, understandings, and representations.

Clause 13 – Amendments

Any amendment or modification to this Contract must be in writing and signed by both parties.

Clause 14 – Notices

All notices required or permitted under this Contract shall be in writing and delivered by hand, post, or email to the contact details provided above and shall be deemed received when delivered.

Clause 15 – Severability

If any provision of this Contract is found to be invalid or unenforceable, the remainder of the Contract shall remain in full force and effect.

Clause 16 – Counterparts

This Contract may be executed in counterparts which together shall constitute one instrument.
