Clause 1 – Scope of Services

The Service Provider agrees to provide the services described above to the Client in a professional and timely manner, consistent with industry standards and applicable Australian laws.

Clause 2 – Term

This Agreement commences upon execution by both parties and continues until the completion of the services or termination in accordance with this Agreement.

Clause 3 – Fees and Payment

The Client agrees to pay the Service Provider the fees specified above. Payment shall be made within the agreed timeframe. Late payments may incur interest at the highest rate permitted by law.

Clause 4 – Confidentiality

Both parties agree to keep confidential all non-public information obtained in connection with this Agreement and shall not disclose such information except as required by law or with prior written consent.

Clause 5 – Intellectual Property

All intellectual property rights arising from the services provided under this Agreement shall be owned by the Client, except where otherwise agreed in writing.

Clause 6 – Liability and Indemnity

The Service Provider shall perform services with due care and skill. To the extent permitted by law, the Service Provider's liability for any claim arising out of this Agreement shall be limited to the fees paid. Each party indemnifies the other against claims arising from breach of this Agreement or negligence.

Clause 7 – Termination

Either party may terminate this Agreement by giving written notice if the other party breaches any material term and fails to remedy within 14 days of notice. Upon termination, the Client shall pay for all services rendered to date.

Clause 8 – Dispute Resolution

The parties agree to resolve disputes amicably. If unresolved, disputes shall be submitted to mediation in accordance with the Australian Dispute Resolution procedures before pursuing legal action.

Clause 9 – Governing Law and Jurisdiction

This Agreement is governed by the laws of Australia. The parties submit to the non-exclusive jurisdiction of the courts of the state or territory where the Client resides or the services are performed.

Clause 10 – Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements, representations, or understandings, whether written or oral.

Clause 11 – Amendments

No amendment of this Agreement is effective unless made in writing and signed by both parties.

Clause 12 – Force Majeure

Neither party shall be liable for failure or delay in performance due to causes beyond their reasonable control, including natural disasters, acts of government, or other unforeseeable events.

Clause 13 – Notices

All notices under this Agreement must be in writing and sent by hand delivery, pre-paid post, or email to the addresses listed above or as otherwise notified.

Clause 14 – Privacy

The parties agree to comply with the Australian Privacy Principles in the handling of any personal information exchanged under this Agreement.

Clause 15 – Severability

If any provision of this Agreement is found invalid or unenforceable, the remainder shall remain in full force and effect.

Clause 16 – Counterparts

This Agreement may be executed in counterparts, each of which is an original and all of which together constitute one agreement.

Clause 17 – Independent Contractors

The parties acknowledge that they are independent contractors and nothing in this Agreement creates a partnership, joint venture, or employment relationship.

Clause 18 – Liability Exclusions

To the extent permitted by law, neither party shall be liable for indirect, incidental, consequential, or punitive damages arising out of this Agreement.

Clause 19 – Compliance with Laws

Each party agrees to comply with all applicable Australian laws and regulations in performing their obligations under this Agreement.

Clause 20 – Signatures

The parties have executed this Agreement as of the date first written above, intending to be legally bound.
