Term and Termination:

Either party may terminate this Agreement by giving written notice to the other party. Upon termination, the Coach shall be entitled to payment for all services rendered up to the date of termination.

Confidentiality:

The Coach agrees to keep all Client information confidential and not disclose any proprietary information to third parties without prior written consent, except as required by law. This obligation survives the termination of this Agreement.

Intellectual Property:

All materials, methodologies, and intellectual property provided by the Coach remain the property of the Coach. The Client is granted a non-exclusive, non-transferable right to use such materials solely for personal use during the coaching engagement.

Liability and Indemnity:

To the maximum extent permitted by law, the Coach excludes all liability for any loss or damage arising out of or in connection with the coaching services. The Client indemnifies the Coach against all claims arising from the Client's use

of the services or materials.

Dispute Resolution:

In the event of any dispute arising out of or relating to this Agreement, the parties agree to first attempt to resolve the dispute through good faith negotiations. If unresolved, the dispute shall be referred to mediation before pursuing any other remedies.

Governing Law and Jurisdiction:

This Agreement shall be governed by and construed in accordance with the laws of Australia. The parties submit to the exclusive jurisdiction of the courts of the relevant State or Territory.

Entire Agreement:

This Agreement constitutes the entire agreement between the parties relating to the subject matter herein and supersedes all prior understandings, agreements, or representations.

Amendments:

Any amendment or modification to this Agreement must be in writing and signed by both parties.
