Clause 1 – Agreement to Sell and Purchase

The Seller agrees to sell and the Buyer agrees to purchase the Lance described herein on the terms and conditions set forth in this Contract.

Clause 2 – Condition of Lance

The Lance is sold 'as is', 'where is', with all faults. The Buyer acknowledges having inspected the Lance or having had the opportunity to do so and accepts the Lance in its current condition.

Clause 3 – Title and Ownership

The Seller warrants that they are the legal owner of the Lance and have full right to sell it. The Lance is free from all encumbrances, liens, charges, and any third-party claims.

Clause 4 – Inspection and Acceptance

The Buyer has the right to inspect the Lance prior to completion of sale. No claims for defects or damages will be accepted after completion unless expressly noted in this Contract.

Clause 5 – Purchase Price and Payment

The total purchase price shall be paid as agreed in the Payment Method section above. Payment shall be made in full

prior to or at the time of delivery.

Clause 6 – Delivery

Delivery of the Lance shall occur at the agreed location. Risk and title pass to the Buyer upon delivery. The Seller shall ensure the Lance is ready for transfer at the delivery location.

Clause 7 – Warranties

Except as expressly provided in this Contract, the Lance is sold without any warranties, express or implied, including but not limited to warranties of merchantability or fitness for a particular purpose.

Clause 8 – Taxes, Duties, and Fees

All taxes, duties, and fees related to the sale, transfer, and registration of the Lance shall be borne by the Buyer, except as otherwise agreed in writing.

Clause 9 – Default

If either party defaults in their obligations under this Contract, the non-defaulting party may seek remedies available under Australian law including specific performance or damages.

Clause 10 – Governing Law

This Contract shall be governed by and construed in accordance with the laws of the Commonwealth of Australia and the State or Territory where the Lance is located.

Clause 11 – Dispute Resolution

In the event of a dispute arising out of or relating to this Contract, the parties shall attempt to resolve it amicably. Failing which, the dispute may be referred to mediation or arbitration under Australian law.

Clause 12 – Entire Agreement

This Contract constitutes the entire agreement between the parties and supersedes all prior agreements, negotiations, and understandings relating to the sale of the Lance.

Clause 13 – Amendments

Any amendments or variations to this Contract must be made in writing and signed by both parties.

Clause 14 – Notices

Notices under this Contract must be in writing and delivered by hand, registered post, or a recognized electronic communication method to the addresses set out herein.

Clause 15 – Severability

If any provision of this Contract is found to be invalid, illegal, or unenforceable, the remaining provisions shall continue in full force and effect.

Clause 16 – Counterparts

This Contract may be executed in counterparts, each of which shall be deemed an original, and all of which together constitute one and the same instrument.

Clause 17 – Signatures

Both parties agree to the terms of this Contract and signify their acceptance by signing below.
