## Custody and Care Arrangements:

The parties agree to share custody of the child as follows: joint legal custody, with primary physical custody granted to Parent/Guardian 1. The child shall reside with Parent/Guardian 1 during the school term, and with Parent/Guardian 2 during school holidays and agreed periods. Both parents shall consult on major decisions regarding the child's health, education, and welfare.

## Parental Responsibilities and Rights:

Each parent agrees to maintain a loving and supportive relationship with the child. Both parties shall provide financial support as mutually agreed and consistent with Australian law, including contributions to schooling, medical expenses, and extracurricular activities. Neither parent shall speak disrespectfully about the other in the presence of the child.

## Visitation Schedule:

Parent/Guardian 2 shall have visitation with the child every alternate weekend from Friday 5pm to Sunday 7pm, and on public holidays as agreed. Additional visitation may be arranged by mutual consent. Both parents agree to provide reasonable notice of any changes.

## Medical Care and Emergencies:

Both parents shall have access to the child's medical records and be informed promptly of any medical emergencies. Each parent shall maintain adequate medical insurance coverage for the child. Decisions regarding major medical treatments shall require the consent of both parents.

## Education:

Both parents shall contribute to decisions regarding the child's education, including choice of school and participation in extracurricular activities. Each parent agrees to support the child's educational needs.

## Dispute Resolution:

In the event of any dispute arising from this Agreement, the parties agree to attempt resolution through mediation before seeking any court intervention. This Agreement is intended to be enforceable under the laws of Australia, and any legal proceedings shall be conducted in the appropriate Australian jurisdiction.
