## Purpose of Agreement:

The purpose of this Agreement is to establish parenting arrangements for the child(ren) named above, promoting their best interests, welfare, and development, consistent with the Family Law Act 1975 (Cth) and applicable Australian family law.

## Parental Responsibility:

**Relocation:**

Neither parent shall relocate the child(ren) permanently without the written consent of the other parent or an order of the court. Any proposed relocation must be communicated with reasonable notice.

**Dispute Resolution:**

In the event of disputes arising from this Agreement, parents agree to attempt mediation or family dispute resolution before seeking court intervention, in accordance with Australian family law requirements.

**Confidentiality:**

Parents agree to keep the terms of this Agreement and any related information confidential except to the extent required by law or as necessary for enforcement or dispute resolution.

**Variation and Review:**

This Agreement may be varied or amended only in writing signed by both parents or by court order. Parents agree to review this Agreement periodically in the best interests of the child(ren).

**Legal Compliance and Enforceability:**

This Agreement is intended to be legally binding and enforceable under Australian law, consistent with the Family Law Act 1975 (Cth) and relevant state legislation.

**Governing Law:**

This Agreement shall be governed by and construed in accordance with the laws of the Commonwealth of Australia.
