Neither party shall be liable to the other for any indirect, incidental, consequential, or punitive damages arising from

this Agreement. Each party shall indemnify and hold harmless the other from any claims arising out of breach or negligence related to this Agreement.

6. Confidentiality:

Both parties agree to keep confidential any proprietary or sensitive information disclosed during the term of this Agreement and use such information only for its purposes.

7. Governing Law and Jurisdiction:

This Agreement shall be governed by and construed in accordance with the laws of Australia. The parties submit to the exclusive jurisdiction of the courts of Australia for any disputes arising under or in connection with this Agreement.

8. Entire Agreement:

This Agreement constitutes the entire agreement between the parties relating to its subject matter and supersedes all prior agreements and understandings, whether written or oral.

9. Amendments:

No amendment or modification of this Agreement shall be valid unless in writing and signed by both parties.

10. Notices:

All notices and communications required or permitted under this Agreement shall be in writing and delivered by hand, prepaid mail, or electronic means to the addresses specified by the parties.
