The Purchaser grants the Vendor a security interest over the financed goods and any proceeds thereof, including any rights to repossession and enforcement under the Personal Property Security Act 2009 (Cth) and related legislation. The Purchaser agrees to sign any documents and take any actions necessary to perfect and maintain the security interest.

Representations and Warranties:

Each party represents and warrants to the other that it has full power and authority to enter into this Agreement and perform its obligations. The Purchaser warrants that it has obtained any required consents and approvals to enter this Agreement. The Vendor warrants that it holds good title to the financed goods, free from encumbrances except as disclosed.

Default:

If the Purchaser defaults in payment or breaches any term of this Agreement, the Vendor may give notice requiring remedy within a specified period. If not remedied, the Vendor may repossess the secured goods, exercise rights under the PPSA, and recover any outstanding amounts plus costs.

Governing Law and Jurisdiction:

This Agreement is governed by and construed in accordance with the laws of the Commonwealth of Australia and the

State or Territory where the Vendor's principal place of business is located. The parties submit to the exclusive jurisdiction of the courts of that State or Territory.

Privacy and Personal Information:

The parties acknowledge their obligations under the Privacy Act 1988 (Cth) and agree to handle each other's personal information in accordance with applicable privacy laws. Personal information will be used solely for purposes related to this Agreement.

Miscellaneous:

This Agreement constitutes the entire agreement between the parties. Any modifications must be in writing and signed by both parties. If any provision is invalid, the remainder shall remain in effect. Headings are for convenience only and do not affect interpretation.
